(ii) Diploma/ Degree courses and Post Graduation in Pharmacy.

(iii) Post graduate Degree course in Computer Application (MCA).

(iv) Post graduate Degree course in Business Administration (MBA).

(v) Admission in 2nd year Degree course in Engineering (Lateral Entry) from amongst Diploma holders.

(vi) Diploma/ Degree course in Hotel Management & Catering Technology

3. The following are the guidelines for admission to the above mentioned courses:-

(i) The condition of domicile requirement for Kashmiri Migrants is waived off.

(ii) One seat in each Polytechnic/Engineering College is hereby created on supernumerary basis of admission of wards of Kashmiri Migrants.

(iii) Admission shall be made only on the basis of marks obtained in JEE (Main)-2017/CMAT-2017/GPAT-2017 Examination conducted by the Central Board of School Examination, and M.S. University, Baroda. In respect of courses, where there is no entrance test, the admission shall be made on the basis of marks obtained in 10th/10+2/Diploma merit wise. However for the seat of Thapar University, Patiala "A Candidate sponsored must have passed 10+2 or equivalent examination with at least 60% (55% for SC/ST Candidates) marks in aggregate of three subjects, namely, Physics, Mathematics and any one subject out of Chemistry, Biology, Biotechnology and Technical Vocational subject OR Minimum 60% (55% for the SC/ST candidates) marks in a Diploma recognized by AICTE or a State Board of Technical Education of at least 3 year duration".

(iv) Application for admission shall be called by the Director, Technical Education & Industrial Training and seats would be allocated to the students at the earliest possible.
