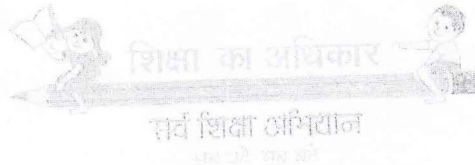

As you may be aware, the Ministry of Human Resource Development has initiated a web based 'All India Survey on Higher Education (AISHE)' to create a robust and sound data base on the large and diverse system of higher education in the country. A dedicated portal <http://aishe.gov.in> has been created for this purpose, where all the required documents including e-version of Data Capture Format are available for the State/institute level users. Using the data collected through this survey, All-India, State level reports could be generated for a better understanding of situation of education. The survey covers information on enrolment at various levels, human resources, infrastructure, income and expenditure etc. for all types of institutions engaged in higher education - arts, science, agriculture, teacher education, management, engineering including polytechnics, medical and nursing.

AISHE 2012-13 has been launched by the Minister of State in the Ministry of Human Resource Development on 03.09.2013. For this survey (2012-13), all the institutions of higher education are expected to upload the data on the portal by 31st March, 2014. I would like to once again remind that the data uploading for AISHE (2011-12) by the institutions is under process. As such, AISHE (2011-12) will also be simultaneously operational with AISHE (2012-13). In this regard my earlier letter no. 19-5/2013 may also be referred to.


In the above context, you are requested to kindly instruct the State Nodal Officer to coordinate the AISHE 2011-12 and 2012-13 related activities to ensure uploading of data capture formats by all institutions in your State on the portal. It may also be noted here that there is no change either in data capture format or software for AISHE 2012-13 vis-à-vis AISHE 2011-12.



Facility to pre-fill basic and static information with the option to edit from the previous year survey data has been provided to avoid unnecessary data entry of the items which do not change frequently. Institutions may be requested to upload the 2012-13 data only after uploading 2011-12 data.


I shall be grateful if you could take appropriate action to ensure timely uploading of the data by institutions under your jurisdiction in the prescribed formats for AISHE - 2011-12 by extended date of 30th November, 2013 and 2012-13 by 31st March, 2014.
