The village Nanowal Vaid is located on the Hoshiarpur Tanda road about 7 kms from Tanda. It is located roughly in proximity of 31°38'N latitude and 74°21' and 74°41'E longitude. It is well connected to towns like Tanda (7 km), Hoshiarpur(23km) and Jalandhar (45 km). The state government will provide free land to start the polytechnic.
