A meeting of Project Steering Committee for Aadhaar Project in Punjab was held on 12/11/2014 4:00 PM under chairmanship of Secretary Planning —cum— Nodal Officer, UID Project, Punjab in Committee Room of Punjab State Planning Board, SCO 70-72, Sector 17-D, Chandigarh.

The agenda of the meeting was included

- 1) To review the progress of Aadhaar seeding of beneficiary data of various schemes of the state departments.
- 2) To finalize specific action plan to complete the standardization and Aadhaar seeding by December 2014.

The following issues were discussed and decisions were made thereof:



- 1) Nodal Officer, Registrar, UID, Punjab explained the agenda of the meeting. He mentioned the names of center sponsored welfare schemes. He informed the members that Government of India has given the deadline to complete the data standardization and Aadhaar seeding of beneficiary data of Scholarship Schemes, NSAP, PDS and NREGA by December 2014. Chairman elaborated that Worthy Chief Secretary has asked the departments to do the standardization and Aadhaar seeding of both center and state schemes and the departments are required to device their strategies to achieve the same.
- 2) Nodal Officer informed the chair that the departments are required to develop an application to maintain the standard in information and de-duplication. Welfare department is using its portal for Post Matric schemes. There is no application is being used for Pre Matric schemes. He informed that the School Education department has built a web based portal in which they have the information of all students. He proposed that the same portal may be used to record the scholarship information of the schools and integration may be done with the welfare portal. He requested Director Welfare to hold a coordination meeting with education department to work out the solution. Director Welfare intimated the chair that the department is in touch with NIC for extending the scope of the existing portal to cover Pre-matric schemes. Chairman asked the department to pursue the matter with NIC for early implementation. If the things do not get mature, they can contact Nodal Officer, Registrar, UID, Punjab for inclusion of application in ICT proposal, within two weeks.
- 3) It was observed that most of the departments have already achieved 77% seeding. It was also observed that the overall progress of seeding in DPI (Collages) Schemes is 86%, but seeding in Districts SAS Nagar and Tarn Taran are on lower side i.e. 66% and 69% respectively. Chairman asked the departments to put a serious effort to seeding Aadhaar. He asked all the departments to achieve 90% seeding and submit achievement report in next two weeks.
- 4) OSD (Scholarships) informed the chair that due to some technical issues, they could not integrate scholarships with ePunjabSchool portal in the current session. From the next session onwards the scholarship information will also be maintained on the same portal. Nodal Officer, Registrar, UID, Punjab proposed that the Aadhaar number of students may be collected at the time of admission itself and the Aadhaar column may be added in the school / college registers / portal.
- 5) Nodal Officer, Registrar, UID, Punjab requested the departments to identify the eligible beneficiaries using Aadhaar. Chairman approved the proposal of Nodal Officer, Registrar, UID, Punjab and asked the departments to issue necessary instructions.
- 6) It was informed that the Health department has seeded Aadhaar against 76% beneficiaries of Matritav Sahyog Yojna (MSY) but the seeding in bank accounts is lacking behind. Chairman explained that during last meeting of State Level Banking Committee (SLBC), banks has discussed issue of transfer of beneficiary information from departments to banks for Aadhaar seeding. It was decided that the banks will accept the



digitally signed information from the official email IDs of the departments only. He asked the department to send the digitally signed information to the bank. He also directed that in case digital signatures are not available, they shall send the PDF/Excel files to lead bank managers from Head of the Department's official email ID. He asked the departments to ensure the verification and de-duplicate of the beneficiary lists at their end before submitting it to banks.

- 7) Chairman asked the departments to send the district wise IFSC wise data of beneficiaries, for which Aadhaar numbers are already available, to banks, for Aadhaar seeding into bank accounts. The departments shall provide supplementary lists to banks after completing the seeding at their end.
- 8) Chairman asked the Social Security Officials that the master information of their databases is required to be standardized first. He instructed the officials to prioritize the work of NSAP schemes and after completing NSAP schemes, the work of state schemes should be completed.
- 9) Joint Secretary, Food —cum— Nodal Officer, Registrar, UID, Punjab informed the chair that they have completed 53% seeding of ration card beneficiaries. Chairman recognized that the quantum of the task for PDS department is must higher than other department and the department is required to frame a specific action plan. He asked the Joint Secretary, Food to submit an action plan to complete field exercise to achieve 80% Aadhaar seeding in four weeks.
- 10) Nodal Officer Registrar, UID, Punjab requested the chair that the Aadhaar enablement work of Education and Transport departments should be started soon, as both of these enablements are undertaken in ICT scheme. It was decided that UID team will visit both the offices and coordinate with technical team for further action.
- 11) Chairman asked that the committee will again meet after 2 weeks to review the progress.

Meeting ended with the vote of thanks to the chair.
