Issues discussed and decisions taken:-

1. Registration of students who have registered on the portal but have not applied for the scholarship till a period of 10 days should be treated as expired and may be deleted so that the student is able to register again. This message is to be flashed on the home page and also to be included in FAQs.
2. Admission Date to Hostel to be made mandatory in case student is hosteller.
3. All Report formats were discussed and finalized. After making necessary modifications, the document will be sent to Dept. of Welfare for approval and after that will be sent to NIC MP for development.
4. Punjab Scholarship portal is not getting listed in Google search yet make it searchable in Google so that the student do not face any difficulty in getting the URL of the Punjab scholarship application.
5. The link to the Punjab scholarship portal to be included on the official website of the Punjab Govt. This is to be taken by Welfare Department with DGR
6. The temporary rejection option be made functional in institute login.
7. The committee for the recruitment of Data Entry Operator for help desk activities will be formed by NIC with the concurrence of Department of Welfare.
8. The last date of applying online by the student to the institute may be extended from 31<sup>st</sup> August to 10<sup>th</sup> September 2013, as demanded by the implementing departments.
