In partial modification of Punjab Government Notification No.08/12/2017-4TE2/953557/1 dated 11.04.2017 (B.Tech. & B.Arch.), in view of the clarification by Council of Architect, the Governor of Punjab is pleased to amend the same as under:-

2.0(b) on the page No.2 the eligibility may be read as:

(i) No candidate, with less than 50% marks in aggregate, shall be admitted to the Architecture course unless he/ she has passed an examination at the end of the new 10+2 scheme of Senior School Certificate Examination or equivalent with Mathematics as subjects of examination at the 10+2 level.

Or

Candidates who have passed 10<sup>th</sup> + 3 year Diploma with subject of Mathematics duly recognized by Central/ State Government as equivalent to 10+2 Level with minimum 50% aggregate marks are also eligible for admission to B.Arch. Course.

Or

International Baccalaureate Diploma, after 10 years of schooling, with not less than 50% marks in aggregate and with Mathematics as compulsory subject of examination.

(ii) All admissions to Architecture degree courses shall be subject to passing of National Aptitude Test in Architecture (NATA) conducted by the Council of Architecture and Marks secured in the qualifying examination in the ratio of 50:50.

\*Vacant seats (if any) can be filled on the basis of Paper-2 (JEE-Main) conducted by CBSE or on the basis of aptitude test in Architecture to be conducted by I.K. Gujral Punjab Technical University, Jalandhar.
