1.0 The Governor of Punjab is pleased to appoint the Punjab Technical University, Jalandhar (hereinafter PTU) as the competent authority to make admission to 2<sup>nd</sup> year (3<sup>rd</sup> semester) of B. Pharmacy. The admission shall be made in the following institutions located in the State of Punjab for the academic session 2013 – 2014 the passed out diploma in Pharmacy are only eligible for this admission:-

Note: The vacant seats in 1<sup>st</sup> year of B. Pharmacy Course for the academic session 2012 – 13 shall also be filled on the inter-se-merit in qualifying examination.

2.0 The Governor of Punjab is also pleased to further issue the following criteria for making admissions thereafter:

#### A. ELIGIBILITY CRITERIA

The minimum qualification for admission to 2<sup>nd</sup> year (3<sup>rd</sup> semester) of B. Pharmacy courses shall be as follows:

(i) All those candidates who have passed the diploma in Pharmacy from an Institution affiliated to the Punjab State Board of Technical Education & Industrial Training / Punjabi University, Patiala or any other University or any State Board of Technical Education shall be eligible to apply. Further, the diploma in Pharmacy and the institute where the candidate has studied must be duly approved by the Pharmacy Council of India / AICTE. Also the candidate should have obtained atleast 45% marks (40% in case of candidate belonging to SC/ST category) in the above mentioned qualifying examination.

(ii) Students directly admitted to the Pharmacy 2<sup>nd</sup> year have to pass those subjects of B. Pharmacy 1<sup>st</sup> year which have not been covered under D. Pharmacy.

### B. ELIGIBILITY FOR ADMISSION TO B. PHARMACY COURSE

- (i) The admission of candidates of the Pharmacy course under this scheme shall only be given to those who fulfils all other conditions for admission. In case of seats reserved for SC/ST, the relative merit shall be determined within the reserved category.
- (ii) Candidates who have appeared / are appearing in the qualifying diploma examination to be held during the current session shall also be eligible for submission of admission form but they will have to pass the diploma in Pharmacy before the date of counselling. Otherwise, they will not be considered for admission to B. Pharmacy course.
- (iii) Apart from the basic educational qualifications prescribed above, the general eligibility criteria shall be as contained in Punjab Government, Department of Technical Education & Industrial Training memo No. 35/44/95-1T(2)/978 dated 21<sup>st</sup> March, 2003. This communication shall be treated, as a part and parcel of this notification shall be read along with the contents of the said communication.
- (iv) The guidelines issued for the grant of resident certificates / bonafide resident of Punjab by Department of Personnel and Administrative Reforms (PP-2 Br) vide No. 1/3/95-3PP-2 / 9619 dated the 6<sup>th</sup> June, 1996, and I.D. No. 1/2/96-3PP-2/8976 dated 7<sup>th</sup> July, 1988, and No. 1/3/95-3PP-2/80 dated 1st January 1999, and further instructions, issued by that Department, if any, will be adhered to in letter and spirit while making admission to the Degree Courses in the Colleges. However, children of defence personnel posted in Punjab are exempted from this condition to the extent that they should have passed only qualifying examination from a recognized institution situated in Punjab.

#### Exemption under above Para

Children/wards/dependent (whose parents are not alive) of those regular Punjab Government employs, members, of All India Service borne on Punjab cadre, Serving judges and the employs of the Punjab and Haryana high court, employs of Boards/Corporations/statutory Bodies established by an act of the state of Punjab who have been holding post outside Punjab on or before 1st January, of entrance test that is on ior before 1st January 2012 and their children/wards/dependents may have done diploma outside Punjab.

#### C RESERVATION:

- i. The reservation of seats shall be as per Punjab Govt, Department of Technical Education and Industrial Training Memo. No. 13 / 2 / 05 –1TE2/409 dated 20<sup>th</sup> February, 2006, which is annexed to this notification, This communication shall be treated as a part and parcel of this notification, for all purposes, and all the provisions of this notification shall be read along with the contents of the said communication.
- ii. The attention of the applicants desirous of claiming reservation under any category whatsoever is especially drawn to the condition and stipulation that only the certificates that have been produced the time of admission shall be considered. The candidates are accordingly advised, in their own interest, to get the requisite certificates issued well before the date of admission, otherwise, claim for reservation shall be summarily rejected.

iii. Candidates are rquired to claim reservation at the time of registering for on-line counselling. If no reservation is claimed, the candidate shall be treated and considered

as "General Category candidate".

iv. The attention of the applicants desirous of claiming reservation under any category whatsoever is especially drawn to the condition and stipulation that only the certificates that have been issued on or before the last date of submission of application forms for admission to second year/3<sup>rd</sup> semester to PTU and have been annexed with the application forms, shall be considered. The canidates are accordingly advised, in their own interest, to get the requisite certificates issued well before the cut-off date, otherwise, their certificate shall not be considered and their claim for reservation shall be summarily rejected. No extension shall be granted in this regard, under any circumstances; this provision should be given wide publicity and also included conspicuously in the prospectus-cuminformation brochure to be issued by the PTU.

v. The PTU shall make a provision in the online application form for a candidate to indicate the category, if any, under which he/she is seeking reservation. There shall also be a provision to indicate the sub-category of the category, if any, under which reservation is being sought, so that inter se gradation can be facilitated. These sub-categories have been elucidated in the Punjab Government, Department of Technical Education and Industrial Training Memo. No., 13 / 2 / 05 –1TE2/409 dated 20<sup>th</sup> February, 2006, which is annexed to this notification. Punjab Government may also set up a committee to effect inter se gradation of candidates claiming reservation under certain categories, as

indicated in the aforesaid memo dated 20th February, 2006.

vi. A candidate shall be eligible to make claim for reservation in any of the reserved categories. However, the procedure for counselling shall be as per Punjab Government. Welfare Department (Reservation Cell) Memo no.7/21/2004-RS1.1674-1677 dated 20<sup>th</sup> Dec., 2004.

## D. General Conditions:

(i) There shall be centralized online counselling by PTU. The Procedure for online counselling shall be decided by the PTU.

(ii) The students shall be liable to pay fee / development fee and off er charges as per the rates of fees / development fee and other charges to the concern college as fixed by

the Government of Punjab/AICTE/ University, from time to time.

(iii) The management quota shall be as per Punjab Government Department of Technical Education and Industrial Training Memo no. 13/129/2003-1TE2/1247 dated 25<sup>th</sup> April 2008 and partial Notification No. 13/129/2003-1TE/1892 Dated 20<sup>th</sup> June 2008 and partial notification no 13/129/2003-1TE2/171dated 18<sup>th</sup> January 2011 which are annexed to this notification.

- (iv) Processing for allocation of seats through counselling shall be done as follows:
  - General category (Punjab Residents only)
  - Reserved Category (Punjab Residents only)
  - General Category (Outside Punjab for vacant seats only)
  - d. Reserved category (Outside Punjab for vacant seats only)
  - e. Inter-se Merit in qualifying exam (For Vacant Seats city)
    Seats remaining unfilled in any category shall be transferred to the respective category and the same shall be filled by the college strictly in the order as mentioned above.

- f. The seats still remaining unfilled, even after the end of counseling shall be transferred to management quota seats, which shall be finalized within 15 days of the last date of counselling.
- (v) The guidelines for admission of Foreign Nationals/PIO shall be as per Punjab Government Notification No. 13/75/2001-1TE2/296 dated Chandigarh the 23<sup>rd</sup> January, 2002.
- (vi) Non refundable counselling fee of Rs. 2000/- (Rupees Two Thousand only) will be collected by the University as counselling fee from each student one time only.
- (vii) In case a student changes his/her/college /University during entralized counselling conducted by PTU his/her fee shall be refunded by the pe vious institution after deduction of Rs 1000/- only the original documents will be refun led immediately.
- (viii) In case a student surrenders his/her seat, within 7 days of the end of the online counselling, he/she must submit application to college and register online on PTU website <a href="https://www.ptuadmissions.nic.in">www.ptuadmissions.nic.in</a>. PTU shall only forward such cases to the concerned colleges/ Universities and colleges must refund his/her full fee after detection of Rs 1000/- only.
- (ix) In keeping with the direction of Ministry of Human Resource Development Department, Govt. Of India all institutions and Universities shall in public interest, maintain a waiting list of students, candidates. In the event of a student/candidate with drawing before the start of the course, the waiting list candicates should be given admissions against the vacant seat. The entire fees collected from the student, after a deduction of processing fee of not more than Rs. 1000/- (Rupees One Thousand Only) shall be refunded and returned by the Institution/University to the student/candidate with drawing from the programme. It would not be permissil; le for institutions and universities to retain the school/institution leaving certificates in original. If a student leave after joining the course and if the seat subsequently falling vacant gets filled by another candidate by the last date of admission, the institution must return the fees collected with proportionate deduction of monthly fee and proportionate hostel rent, where applicable.

(E) Over-riding Provision:

Nothing in this notification shall be operative in so far as it is inconsistent with the law of the land as laid down of the judgement of the honorable Supreme Court of India in the case of TMA Pai Foundation and others vs. State of Karnataka and others ((2002) 8 SCC 481:AIR 2003 SC 355). Any such inconsistency may be brought to the notice of the Government of Punjab, clearly highlighting the inconsistency, for immediate rectification.
