It is notified for the Kashmiri Migrants and Kashmiri Pandit/ Kashmiri Hindu Families (Non-Migrants) living in Kashmir valley that the Department of Technical Education & Industrial Training, Government of Punjab after considering the guidelines issued by All India Council for Technical Education and Ministry of Human Resources Development has reserved one seat in each Engineering/MBA/MCA/Hotel Management & Catering Technology in Thapar Institute of Engineering & Technology, Patiala, Punjabi University, Engineering Colleges and Polytechnic Colleges of the State for admission of wards of Kashmiri Migrants for the academic session 2024-25.

Courses:-

- (i) Diploma/Degree courses in Polytechnic/Engineering Colleges.
- (ii) Post graduate Degree course in Computer Application (MCA).
- (iii) Post graduate Degree course in Business Administration (MBA).
- (iv) Admission in 2nd year Degree course in Engineering (Lateral Entry) from amongst Diploma holders.
- (v) Diploma/Degree course in Hotel Management & Catering Technology.
- A. The following are the guidelines for admission to the above mentioned courses:-
 - (i) One seat in each Polytechnic/Engineering College is hereby created on supernumerary basis for the year 2024-25 of admission of wards of Kashmiri Migrants and Kashmiri Pandit/Kashmiri Hindu Families (Non-Migrants) living in Kashmir valley.
 - (ii) Admission to various Degree/Diploma level Engineering Courses shall be made on the basis of Inter-se-Merit of Qualifying Examination. However for the seat of Thapar Institute of Engineering & Technology, Patiala, the candidate
 - I. must have passed 10+2 or equivalent examination with at least 60% marks (55% for SC/ST candidates) in aggregate of three subjects, namely, Physics, Mathematics and any one subject out of Chemistry, Biology, Biotechnology and Technical Vocational subject

- II. Have passed 10+2 examination in 2022 or 2023 or appearing in 2024.
- III. Has appeared in JEE(Main)-2024.
- (iii) Kashmiri Pandits/Kashmiri Hindu Families (Non-Migrants) living in the Kashmiri Valley need domicile certificate.
- (iv) The condition of domicile requirement is waived off for Kashmiri Migrants only. However, each Kashmiri Migrant candidate shall have to give proof of his being a Kashmiri Migrant or a ward of Kashmiri Migrant along with the Application Form.
- (v) The fees shall be charged as per rates fixed for session 2024-2025 by the State Government/University.

B. <u>COUNSELLING OF CANDIDATES</u>.

- i) Counselling of the candidates shall be held on 27.08.2024 at 11.00 A.M. in the Committee Room of Directorate of Technical Education & Industrial Training, Punjab, Plot No. 1, Sector 36-A, Chandigarh. Only those candidates shall be considered who have applied against these seats in time.
- ii) No separate letter for counseling shall be issued.
