It is notified for the Kashmiri Migrants that the State Government after considering the guidelines issued by All India Council for Technical Education and Ministry of Human Resources Development has reserved one seat in each Engineering /MBA /MCA /M.Pharma / B.Pharmacy/Hotel Management & Catering Technology, Diploma in Engineering in Thapar Institute of Engg. & Tech. Patiala, Punjabi University, Patiala, Engineering Colleges and Polytechnic Colleges of the State for admission of wards of Kashmiri Migrants for the academic session 2018-19.

Courses:-

- (i) Diploma/Degree courses in Polytechnic/Engineering Colleges.
- (ii) Diploma/Degree Courses and Post Graduation in Pharmacy.
- (iii) Post graduate Degree course in Computer Application (MCA).
- (iv) Post graduate Degree course in Business Administration (MBA)
- (v) Admission in 2nd year Degree course in Engineering (Lateral Entry) from amongst Diploma holders.
- (vi) Diploma/Degree course in Hotel Management & Catering Technology.

A. The following are the guidelines for admission to the above mentioned courses:-

1. The condition of domicile requirement for Kashmiri Migrants is waived off.
2. One seat in each Polytechnic/Engineering College is hereby created on supernumerary basis for the year 2018-19 of admission of wards of Kashmiri Migrants.

Admission shall be made only on the basis of marks obtained in JEE (Main) 2018/CMAT-2018/GPAT-2018 Examination. In respect of courses where there is no entrance test, the admission shall be made on the basis of marks obtained in qualifying examination. However for the seat of Thapar Institute of Engg.& Tech., Patiala. The Candidate sponsored must have

passed 10+2 or equivalent examination with at least 60% (55% for SC/ST Candidates) marks in aggregate of three subjects, namely, Physics, Mathematics and any one subject out of Chemistry, Biology, Biotechnology and Technical Vocational subject OR Minimum 60% (55% for the SC/ST candidates) marks in a Diploma recognized by AICTE or a State Board of Technical Education of at least 3 year duration.

3. The fee shall be charged as per rates fixed for session 2018-19 by the State Government/University.
4. Each candidate shall have to give proof of his being a Kashmiri Migrant or a ward of Kashmiri Migrant alongwith the Application Form.

B. COUNSELLING OF CANDIDATES.

- i) Counseling of the candidates shall be held on 20.07.2018 at 10.00 A.M. in the Committee Room of Directorate of Technical Education & Industrial Training, Punjab, Plot No. 1, Sector 36-A, Chandigarh. Only those candidates shall be considered who have applied against these seats in time.
- ii) No separate letter for counseling shall be issued.
