It is notified for the Kashmiri Migrants that the State Government after considering the guidelines issued by All India Council for Technical Education and Ministry of Human Resources Development has reserved one seat in each Engineering /MBA /MCA /M.Pharma / B.Pharmacy/Hotel Management & Catering Technology, Diploma in Engineering in Thapar University, Punjabi University, Engineering Colleges and Polytechnic Colleges of the State for admission of Kashmiri Migrants for the academic session 2016-17.

Courses:-

- (i) Diploma/Degree courses in Polytechnic/Engineering Colleges.
- (ii) Diploma/Degree Courses and Post Graduation in Pharmacy.
- (iii) Post graduate Degree course in Computer Application (MCA)
- (iv) Post graduate Degree course in Business Administration (MBA)
- (v) Admission in 2nd year Degree course in Engineering (Lateral Entry) from amongst Diploma holders.
- (vi) Diploma/Degree course in Hotel Management & Catering Technology.

A. The following are the guidelines for admission to the above mentioned courses:-

1. The condition of domicile requirement for Kashmiri Migrants is waived off.
2. One seat in each Polytechnic/Engineering College is hereby created on supernumerary basis of admission of wards of Kashmiri Migrants.
3. Admission shall be made only on the basis of marks obtained in JEE (Main) 2016/CMAT-2016/GPAT-2016 Examination. In respect of courses where there is no entrance test, the admission shall be made on the basis of marks obtained in qualifying examination. However for the seat of Thapar University, Patiala candidate must have passed 10+2 or equivalent examination with at least 60% (55% for SC/ST candidates) in aggregate of three subjects, namely, Physics, Mathematics and any one subject out of

Chemistry, Biology, Biotechnology and Computer Science or minimum 60% marks (55% marks for SC/ST) in a diploma recognized by AICTE or a State of Board of Technical Education of at least 3 years duration.

4. The fee shall be charged as per rates fixed for session 2016-17 by the State Government/University.
5. Each candidate shall have to give proof of his being a Kashmiri Migrant or a ward of Kashmiri Migrant alongwith the Application Form.

B. COUNSELLING OF CANDIDATES.

i) Counseling of the candidates shall be held on 20.07.2016 at 10.00 A.M. in the Committee Room of Directorate of Technical Education & Industrial Training, Punjab, Plot No. 1, Sector 36-A, Chandigarh. Only those candidates shall be considered who have applied against these seats in time.

ii) No separate letter for counseling shall be issued.
